
(November 20, 2017, Hong Kong) —"Hong Kong Undergraduate Financial Planners of the Year Award 2017" (The Award) organized by Society of Registered Financial Planners ("HKRFP"). The Award are to raise awareness of financial planning among university students, equip them with adequate knowledge for a career in the financial planning industry, provide encouragement and recognition to outstanding participants, and promote professional standards and quality in financial planning.

The competition went through three rounds. Participating teams were asked to submit a detail financial proposal and written report on one real-life financial planning case in the round one. Entries were then assessed in accordance to five criteria, namely, the effective application of client information, formulation of financial goals, construction of a comprehensive financial proposal, risk analysis, and presentation layout. The selected top 13 teams from the first round would then advance to Round Two, in which each team was requested to submit a video presentation alongside with a set of power-point slides on the written case presented as per Round One. In the Final Round, each team had to provide their arguments on the topic "How to beat or cope with ChatBot (Robots that answer and response like human but with a super brain) in the AI transformation in Financial Planning Industry.

Many telephone operations are replaced by chatbot these days. So starting are the legal professions, at least in the USA, and many white collar jobs. Professionals in the financial sector are shaking. Al and robots are coming. What is it in us that they cannot do or think better? Especially in that Al don't lie, they are patient, and they can prepare a tailor make portfolio for clients in seconds. As a new era financial planner, what will you plan to govern Al or override chatbots?" in front of the panel of judges.

The Society of Registered Financial Planners ("HKRFP") announces winners of the "Hong Kong Undergraduate Financial Planners of the Year Award 2017".
