The President's Report is, in my opinion, meant to give a summary of what has been accomplished, what is brewing, and how progresses are with respect to operations of the Society during my term of office, especially for 2011, which is the tenth anniversary of Society of Registered Financial Planners. Hereby I am delighted to state this report to you all, as follows:

Our Development in Hong Kong

Unclear yet negative factors have been clouding the economic outlook for Hong Kong. While the aftermath of the Financial Tsunami and Lehman Brothers crash still lingers on, a slow down in economic recovery among developed nations and the recent European debt crisis spread are adding salt to the wound. An idiom says, "Crisis creates opportunity, and vice versa", professional financial planning practitioners should at this very time maintain their sharp market instincts and professional integrity to strengthen the mutual trust with clients. At this end, we are active in having elite speakers to hold talks on a wide variety of topics in seminars, in general warmly supported by a number of professional organizations, namely, the Hong Kong Accounting Professionals Association, the Institute of Financial Accountants in Hong Kong, the ITAccountants Association, the Institute of Crisis and Risk Management, and the University of Macau (Hong Kong) Alumni Association. These talks are visionary and create an interactive platform between speakers and the audience, composed of practitioners in the financial planning profession. Our Development in the Mainland China

In response to the demand for professional seminars from members of the Guangdong province, we held two seminars in Shenzhen with great success. Mutual Recognition

On Feb 15 2011, the Chairman of the Registered Financial Planner Institute Philippines "RFP(Phils)" Mr. Henry Ong and the President of the Society Dr. Sidney Sze signed a Mutual Recognition Agreement for both organizations. Our members are exempted from two papers, and upon passing other examinations and successful qualification assessment, will be awarded the full membership of RFP(Phils).

Undergraduates Financial Planners of the Year Award 2011

To raise social awareness in financial planning and understanding of the "generalist" nature in a financial planner, for the first time we shall organize a meaningful competition for undergraduates in Hong Kong and Macau. It will be a comprehensive assessment of their understanding about the financial planning market and establishment of their ethical consciousness. The winners will receive internship opportunities and cash prizes offered by The Prudential Assurance Company Limited, Platinum sponsor of this competition, and will also be granted financial planning training and associate member benefits by the Society of Registered Financial Planners.

Social Contribution

The Society is committed to promote community education in financial planning. Our continuous participation at 『財智 Goal 飛』教師社區協作計劃之『第二屆全港理財教育辯論比賽』 the Healthy Budgeting Family Debt Counseling Centre, of the Tung Wah Group of Hospitals is evidenced by the full support as judges in a debate competition from our executive team, led by me, (Vice President)Mr. Alex Lung,(Councilors)Mr. Stephen Ho, Mr.

Calvin Leung and Ms. Maggie Ma, and Vice chairman of the China Development Committee, Mr. James Wong. In this event, secondary school students are educated with positive attitude in financial planning.

Another function the Society had engaged in was a campaign on financial planning education. Organized by the Tung Wah Group of Hospitals Community Service Division Elderly Services Section, our Vice President Mr. Michael FAN was invited to conduct seminars for the elderly community. On November 28, 2010, "妥善理財退無憂" seminar for the elderly was organized, over a hundred senior citizens fostered positive feedbacks and valued the financial planning sections. On May 28, 2011, our Vice chairman of China Development Committee Mr. James Wong hosted retirement financial planning for the elderly. Again, the response was overwhelmingly positive.

We appreciate very much that in five consecutive years the Society has been awarded the "Caring Organization" by the Hong Kong Council of Social Service, logo in recognition is published throughout our media materials. With caring staff, caring environment, we care in excellence.
