The course and developments of our Society in Hong Kong and the China mainland in the past eleven years have been full of surprises and challenges, and proves to be a valuable experience in my life. MEMBERSHIP

As at August 2013, total memberships registered are approximately 3,000, from Hong Kong and China.

HONG KONG UNDERGRADUATE FINANCIAL PLANNERS OF THE YEAR AWARD

Upon a successful launch of the 2011 Hong Kong Undergraduates Financial Planning Award, in which overwhelming support and participation from universities in Hong Kong and Macau was recorded, our Society progressed the 2nd Award competition last year and this challenging event received yet another warm welcome from the academic institutions in the region, and Mr. Vincent Lee, the independent non-executive director of the HKEX, and Permanent Honorable President of the HK Securities Association Ltd. was invited as the guest of honor in the Award final round to host the award hand-out ceremony as well as to share his visions and



experience in the financial industry. The participants have been well benefited in the course of the event and obtained enough knowledge to prepare them for a future career in financial planning. I hereby on behalf of our Society thank you for the professional advice from our colleagues in the industry and the support from the universities in the region, making this Award a fruitful and meaningful event to the society. The Award is now in its third year and is on course for competitors to present their cases during the period from August to November, we look forward to another year of success in this Award and hope to make a great positive impact to our community in

the field of financial planning.

FINANCIAL PLANNING EDUCATION

For the purpose of uplifting the public awareness in financial planning profession, our Society had participated a broadcast program "the Sweetie Family" produced by the HK Radio 2, a very popular community radio channel in Hong Kong. Through the radio sit-com, our council members shared their professional insight and views on family and individual financial planning, which provided the audience the technique to master their own financial issues, healthcare investment, and the factors relating to financial risk and so on. Some of the themes include "Importance of Financial Planning", "MPF", "Types of Securities", "Investment and Speculation", "Financial Planning", "Dividend and Capitalization", and "Margin", "ETF Basics", and "Mutual Funds", "Overseas Properties Acquisition", "Loan and Trap", "The Rights and Liabilities of a Guarantor", "Will and Estates Arrangement", "Insurance", "Consumer Intelligence" and "Beware of Fraud" and some hot topics.
